The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Jessica A. Fadness is licensed in the State of Wisconsin as a Private Security Person, having license number 108-39830, first issued on 01/19/2010 and current through 08/31/2012. Respondent's most current address known to the Department is 412 South Vita Avenue, Beaver Dam, WI 53916. Respondent's most recent address on file with the Department is 511 ½ Louise Lane, Beaver Dam, WI 53916.

2. In September 2010, Respondent submitted a renewal application which indicated that Respondent had been convicted of Operating While Under Influence (2nd) on July 12, 2010.

3. Division of Enforcement Case Number 10 RSG 032 was subsequently opened for investigation.

4. Certified court documents obtained during the course of the Department's investigation confirmed that on July 12, 2010, Respondent was convicted of Operating While under Influence (2nd).

5. Respondent failed to notify the Department of the conviction within 48 hours of the judgment of conviction.

6. Respondent, for personal reasons, elected to resign from the profession of private security in 2010, and has not practiced as a private security person since that time.

7. Respondent wishes to resolve the complaint filed in Division of Enforcement Case No. 10 RSG 032 pursuant to the surrender of her private security person license (108-39830).

8. Respondent does not admit to any violation of Wisconsin statutes or Administrative Code provisions pertaining to private security persons, but for personal and financial reasons she does not wish to contest the findings of fact or conclusions of law herein.

#### CONCLUSIONS OF LAW

1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5)

2. By the conduct described in the Findings of Fact, Respondent violated Wis. Stat. § 440.26(4m)(b) and Wis. Admin. Code § RL 35.01(2) and is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)1 and 2.

#### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The attached Stipulation is hereby accepted.

2. The VOLUNTARY SURRENDER of the Wisconsin private security person license of Jessica A. Fadness (license no. 108-39830) is ACCEPTED. Ms. Fadness shall return all indicia of her Wisconsin Private Security Person licensure to the Department Monitor, P.O. Box 8935, Madison, WI 53708-8935 within ten (10) days following the effective date of this Order.

3. In the event that Ms. Fadness ever seeks to renew her private security person license or apply for any credential issued or renewed under Wis. Stat. chs. 440 to 480, she shall


pay the Department's costs of this matter in the amount of TWO HUNDRED SIXTY-NINE DOLLARS (\$269.00) before any such renewal or application may be considered.


4. In the event that Ms. Fadness seeks to renew her private security person license following the effective date of this Order, the Department may determine whether and under what terms and conditions such request may be granted.

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as ordered and as set forth above, Respondent's license (number 108-39830) may in the discretion of the Department, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of costs.

6. This Order is effective on the date of its signing.
