The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Real Estate Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Susan K. Hietpas (dob 02/19/52) is licensed in the State of Wisconsin as a Real Estate Broker, having license number 49544-90, first issued on 09/29/1998 and current through 12/14/2012. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is W3521 Blackhawk Ave, Redgranite, WI 54970.
- 2. In June 2009, Respondent was the managing real estate broker for Coldwell Banker The Real Estate Group, Inc.

3. As part of her duties as managing broker, Respondent reviewed and approved offers to purchase two condominiums that were made on form WB-11 Residential Offer to Purchase instead of on the prescribed form WB-14 Residential Condominium Offer to Purchase.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Real Estate has jurisdiction to act in this matter pursuant to Wis. Stat. § 452.14, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code § RL 16.04(1) and §§ RL 17.08(1) and (2) by failing to make a reasonable review of all offers to purchase and making sure the prescribed form was used.
- 3. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stat. §§ 452.14(3)(L) and (m).

<u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. Respondent Susan K. Hietpas is hereby REPRIMANDED.
- 3. The Real Estate Broker license issued to Susan K. Hietpas (license number 49544-90) is hereby LIMITED as follows:
 - a. Respondent shall, within one year of the date of this Order, successfully complete 3 hours of continuing education on forms offered by a provider preapproved by the Board's monitoring liaison, including taking and passing any exam offered for the courses:
 - b. Respondent shall submit proof of completion in the form of verification from the institution providing the education to the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board, Wisconsin Department of Safety and Professional Services or similar authority in any state, and also may not be used in future attempts to upgrade a credential in any state.
 - c. This limitation shall be removed from Respondent's license and Respondent will be granted a full, unrestricted license after satisfying the Board or its designee that Respondent has successfully completed all of the ordered education.
- 4. Within 90 days of the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$513.

5. Proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be mailed, faxed or delivered by Respondent to the Department Monitor at the address below:

- 6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as ordered or fails to submit proof of successful completion of the ordered education as set forth above, Respondent's license (no. 49544-90) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs and completion of the education.
 - 7. This Order is effective on the date of its signing.
