The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Edward M. Healey, R.N., (DOB 11/16/01952) is licensed as a professional nurse in the State of Wisconsin (license no. 151298-30). This license was first granted on July 1, 2005.

2. Respondent's most recent address on file with the Wisconsin Board of Nursing is 2129 Vintage Drive, Fitchburg, WI 53575.

3. Respondent currently suffers from a mental health issue which impacts his ability to practice nursing in a safe and effective manner.

4. Respondent has self report and cooperated fully with the Department.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

2. Respondent's condition described in paragraph 3 above supports the surrender of his license pursuant to Wisconsin Administrative Code § N 7.03(3) and Wis. Stat. § 441.07(1)(d).

ORDER

IT IS ORDERED:

1. The SURRENDER of the license of Edward M. Healey to practice nursing in the State of Wisconsin is hereby accepted.

2. The SURRENDER of the privilege of Edward M. Healey to practice nursing in the State of Wisconsin under another state license pursuant to the Nurse Licensure Compact is hereby accepted.

3. In the event that Respondent re-applies for licensure as a nurse in the future, he shall provide the Board with evidence of fitness to practice. The Board may limit Respondent's license in any manner it sees fit to address the facts above and any recommendations resulting from the fitness for practice evidence, including but not limited to direct supervision and quarterly employer work reports.

4. In the event that Respondent ever reapplies for any credential in Wisconsin Respondent shall, prior to such application, pay costs of this proceeding in the amount of one hundred dollars (\$100.00). Payment shall be made payable to the Wisconsin Department of Safety and Professional Services, and mailed to:
