The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Supercuts #90572 is licensed in the State of Wisconsin as a Barbering and Cosmetology Establishment, having license number 80-35361, first issued on 10/12/2007 and current through 3/31/2013. Respondent Supercuts #90572's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is W3165 Van Roy Road, Suite B, Appleton, WI 54915.

2. On or about April 9, 2010, the Department received a complaint alleging that Respondent had been operating without a licensed manager since 2008.

3. The Department's investigation revealed that Respondent operated without a licensed barbering and cosmetology manager from March 2008 until August 26, 2010.

4. In resolution of this matter, Respondent Supercuts #90572 consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent Supercuts #90572 has violated Wis. Stat. § 454.08(6) and Wis. Admin. Code §§ BC 2.06(5) and BC 3.02(1).

3. As a result of the violations noted in the Conclusions of Law, Respondent Supercuts #90572 is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The attached Stipulation is hereby accepted.
2. Respondent Supercuts #90572 is hereby REPRIMANDED.
3. Within 90 days of the date of this Order, Respondent Supercuts #90572 shall pay a forfeiture in the amount of \$2,000.00 and costs of this matter in the amount of \$524.00.
4. Payment of forfeiture and costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of the Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as

ordered, Respondent's license (number 80-35361) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the payment of the forfeiture and costs.

6. This Order is effective on the date of its signing.
