The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Respondent Eileen M. Kuehn, date of birth: 12/31/48, is duly licensed in the State of Wisconsin as a barbering and cosmetology manager, having license number 81-12427. This license was first granted to her on November 21, 1973. The license is current through March 31, 2013.
2. The most recent business address on file with the Wisconsin Department of Safety and Professional Services (Department) for Respondent Kuehn is 1 S. Pinckney Street, US Bank, Madison, WI 53703.

3. Respondent Eileen M. Kuehn is employed at Josie's Studio One Salon (#80-28318; granted: 6/9/99; current through 03/31/13). At all times relevant to this action, Respondent Kuehn was and is responsible for compliance with Wisconsin Statutes Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology, Chapter BC 3.

4. On February 24, 2011, the Department received a consumer complaint alleging that unlicensed activity and unprofessional conduct was taking place at Josie's Studio One Salon. A case was subsequently opened for investigation.

5. The results of the investigation reveal that Respondent Kuehn engaged in booth renting activity without first obtaining a separate barbering and cosmetology establishment license between January 1, 2011 and August 2, 2011.

6. As of August 2, 2011, Ms. Kuehn ceased engaging in booth renting activity and began working as an employee of Respondent Josie's Studio One. As of August 2, 2011, Respondent Kuehn became the manager of record at Josie's Studio One Salon.

7. In resolution of this matter, Respondent Eileen M. Kuehn consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in paragraph five (5) of the Findings of Fact, Respondent Eileen M. Kuehn has violated Wis. Admin. Code § BC 3.02(2)(b) by engaging in booth renting activity without maintaining a separate establishment license.

3. As a result of the violations described in paragraph two (2) of the Conclusions of Law, Respondent Eileen M. Kuehn is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Respondent Eileen M. Kuehn be, and hereby is, **REPRIMANDED**.

IT IS FURTHER ORDERED that:

2. Respondent Eileen M. Kuehn shall pay **COSTS** in the amount of **THREE HUNDRED SEVENTY FIVE DOLLARS (\$375.00)** and a **FORFEITURE** in the amount of **TWO HUNDRED FIFTY DOLLARS (\$250.00)** within 90 days of the date of this Order.

3. Payment of the costs and forfeiture shall be made to the Wisconsin Department of Safety and Professional Services and sent to:

4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs and forfeiture as ordered and as set forth above, then Respondent's license (number 81-12427) may, in the discretion of the board or its designee, be **SUSPENDED**, without further notice or hearing, until Respondent has complied with payment of costs and forfeiture.

5. This Order is effective on the date of its signing.
