The Wisconsin Professional Counselor Section held a Class 1 hearing on November 18, 2011 to consider whether Jessica Brumm-Larson's education is equivalent to a master's degree in professional counseling. Based upon the information of record the Section now hereby finds and makes the following:

FINDINGS OF FACT

1. On June 9, 2011, Jessica Brumm-Larson applied for a professional counselor license.
2. On May 18, 2008, Ms. Brumm-Larson received her master's in Educational Psychology with a concentration in School Psychology. Based upon the information presented at the Class 1 hearing her education was deemed equivalent to a master's degree in Professional Counseling.
3. Ms. Brumm-Larson completed 1,888 of her supervised practice hours at Boys Town Center for Behavioral Health in the state of Nebraska.
4. Ms. Brumm-Larson completed her remaining supervised practice hours required for licensure at Family Options Counseling, LLC and Penfield Children's Center Behavior Clinic, both located in the state of Wisconsin, without a professional counselor training license.

CONCLUSIONS OF LAW

1. The practice of professional counseling in Wisconsin without a professional counselor training license while obtaining hours of supervised practice is a violation of § 457.04(6), Wis. Stat., which is unprofessional conduct as definite by § MPSW 20.02(2), Wis. Admin. Code.


ORDER

NOW, THEREFORE, IT IS ORDERED that Jessica Brumm-Larson is GRANTED a professional counselor license.

IT IS FURTHER ORDERED THAT Jessica Brumm-Larson is REPRIMANDED for obtaining the hours required for licensure without a professional counselor training license.
