On July 19, 2012, the Board of Nursing considered the petitioner's request for modifications of the limitations on his registered nurse license pursuant to the Order Imposing Current Standard Impairment Requirements and Granting Stay of Suspension of the Board dated September 14, 2010 to terminate the therapy requirement and decrease the drug screen frequency. Based upon the information of record which shows support of his therapist to terminate therapy and his current employment is not in the health field, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations on the registered nurse license of Paul Lauer (#106610-30) to decrease the frequency of drug screens is GRANTED.

IT IS FURTHER ORDERED that the frequency of drug screens shall be at least twenty-eight (28) urine screens per year and one (1) annual hair test until such time as Paul Lauer obtains nursing employment. At such time the drug screen frequency shall increase to at least forty-eight (48) urine screens per year and one (1) annual hair test.

IT IS FURTHER ORDERED that the request for termination of the therapy requirement is GRANTED.
