On July 19, 2012, the Board of Nursing considered the petitioner's request for reinstatement of her surrendered registered nurse license pursuant to the Final Decision and Order of the Board dated January 9, 2001. Based upon the information of record which shows it has been over five years since she surrendered her license, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the registered nurse license of Gayle Glynn (#111412-30) is DENIED.

IT IS FURTHER ORDERED that Gayle Glynn shall be granted a LIMITED LICENSE FOR THE SOLE PURPOSE OF COMPLETING A BOARD APPROVED RN REFRESHER COURSE. This limited license is for the sole purpose of completing clinicals as an educational requirement of the RN refresher course. Ms. Glynn shall provide a copy of this Order to the instructors and clinical placement personnel of the RN refresher course.

IT IS FURTHER ORDERED that Ms. Glynn shall not be in a setting in which she has access to controlled substances.

IT IS FURTHER ORDERED that Ms. Glynn shall participate in a Board approved drug monitoring program with the frequency of drug screens to be not less than twenty-eight (28) urine screens and one (1) annual hair test. Ms. Glynn shall provide the Department Monitor with a copy all prescriptions.

IT IS FURTHER ORDERED that the limited license shall be valid for one year from the date of issuance and shall not be renewed except by petition to the Board.

IT IS FURTHER ORDERED that Gayle Glynn may petition the Board for reinstatement of her license upon completion of the RN refresher course. She shall make a personal appearance before the Board in support of her petition. The Board may in its sole discretion determine whether, and under what terms and conditions, her license may be reinstated.
