The Dentistry Examining Board considered this matter at its meeting on March 7, 2012.

BACKGROUND

On September 28, 2005, for the reasons stated in the Final Decision and Order of the same date, the Dentistry Examining Board limited Raymond L. Schneider's dentistry license, number 5001226-15, until such time as Dr. Schneider had fully complied with all terms of the Order. By the terms of the Order, Dr. Schneider was required to complete a minimum of 50 hours of educational course work in dental implants and prosthetics, and to undergo monitoring of his dentistry implant practice for two (2) years. The Board further ordered Dr. Schneider to pay a forfeiture of \$500.00 and costs of the proceeding in the amount of \$15,000.00 within 60 days of the date of the Order.

In conjunction with its Order dated September 28, 2005, the Board appointed Dr. Jeffrey L. Casperson to monitor Dr. Schneider's practice. However, Dr. Casperson's appointment letter was subsequently returned to the Department, and no other professional monitor was appointed. Dr. Schneider did not receive notice of the status of the monitor.

In July 2008, Dr. Schneider provided the Board with satisfactory evidence of his compliance with the educational component of the Order and his forfeiture and costs were paid in full on November 25, 2005.

On or around December 2008, Dr. Schneider resumed practicing implant dentistry. Dr. Schneider submitted the patient lists and information to the Department as required by Section 1.h of the Order dated September 28, 2005. He further authored and submitted the reports that would have been required of a monitor, as described in Section 1.i of the Order. In March 2011, the Department Monitor informed Dr. Schneider that reports from a professional monitor were necessary for him to petition the Board for removal of the limitations on his license.

The Department Monitor received a report dated December 23, 2011 from Kim A. Gowey, D.D.S., regarding Dr. Schneider's dental implant practice for the preceding three years. Dr. Gowey had reviewed the records of the eight patients to whom Dr. Schneider had provided such services, and about whom Dr. Schneider had reported to the Department.

On or about March 3, 2012, Dr. Schneider petitioned the Board for removal of the limitations on his license. The Board reviewed Dr. Schneider's petition at its March 7, 2012 meeting, and based upon the evidence presented, makes the following:

FINDINGS OF FACT

1. Dr. Schneider has complied with the requirements of the Final Decision and Order dated September 28, 2005.

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to remove the limitations placed on Raymond L. Schneider's dentistry license, number 5001226-15, as described in the Final Decision and Order dated September 28, 2005 is hereby GRANTED.

IT IS FURTHER ORDERED that all limitations and encumbrances placed upon Dr. Schneider's license are hereby removed, and his license is restored to full and unrestricted status.
