On February 23, 2012, the Board of Nursing considered the petitioner's request for reinstatement of a limited registered nurse license to enable her to complete a board-approved nurse refresher course. Petitioner's nursing license was revoked pursuant to the order of the Board dated June 9, 2005. Petitioner is required to complete a board-approved nurse refresher course because it has been 5 years or more since the renewal of her license. Based upon the lack of current information demonstrating her rehabilitation and fitness to practice, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of a limited license for KARI GLYDENVAND, R.N. (lic. #120127-30) to complete a nurse refresher course is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall submit a current AODA assessment from a Board-approved treatment provider prior to submitting a petition for a limited license.

IT IS FURTHER ORDERED that petitioner shall submit a comprehensive psychological evaluation from a Board-approved treatment provider prior to submitting a petition for a limited license.

IT IS FURTHER ORDERED that petitioner shall submit verification of her NA/AA meeting attendance for the past three months prior to submitting a petition for a limited license.

IT IS FURTHER ORDERED that all reports, records or petitions shall be mailed or faxed to the Department Monitor who shall submit the petitioner's request before the Board when the requirements are met.
