On August 16, 2012, the Board of Nursing considered the petitioner's request for removal of the suspension which occurred as a result of not completing the continuing education pursuant to the Final Decision and Order of the Board dated August 30, 2007. Based upon the information of record which shows completion of the education and a violation of the Board Order for failure to pay the costs of the original disciplinary proceeding, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for lifting the suspension on the registered nurse license of Angela Mangold (#131794-30) is GRANTED.

IT IS FURTHER ORDERED that the payment plan in the Order dated August 30, 2007 be modified to monthly installments in the amount of \$750.00 with the outstanding balance and interest to be paid in full within twelve (12) months of the date of this Order.

IT IS FURTHER ORDERED that the registered nurse license of Angela Mangold is LIMITED as follows:

- 1. Ms. Mangold shall arrange for quarterly work reports with the Board of Nursing, detailing her compliance with standards of the nursing professions, with particular attention to the accuracy of her documentation and reports of patient assessments and planning. The first quarterly report shall be due ninety days after she begins nursing employment and shall continue to be due every ninety days thereafter, for a period of two years, or, to account for any period during which she is not practicing nursing, until the Board has received eight satisfactory reports from her employer, whichever period is longer.
- 2. Ms. Mangold shall not work in any nursing position except under the direct supervision of another registered nurse who is not employed by or in business with Ms. Mangold's husband, or a physician who is not her husband and who is not employed by or in business with her husband, and she may not be a charge nurse, home health care nurse or temporary nursing services nurse.
