ORDER

NOW, THEREFORE, IT IS ORDERED that the request for return to full licensure status of the registered nurse license of Anne McCarthy Graf (# 93746-30) is DENIED.

IT IS FURTHER ORDERED that Ms Graf shall provide to the Department Monitor a complete fitness to practice letter which addresses the following:

- > Her ability to make good decisions.
- > Her ability to handle stress and critical thinking
- > The current status and prognosis of her recovery
- > Whether she is overall safe to practice
