BACKGROUND

On August 15, 2007, the Wisconsin Medical Examining Board issued a Final Decision and Order (Order) indefinitely suspending Jennifer Nolden's physician assistant license (#748-23). The Order allowed Ms. Nolden to petition for a stay of the suspension conditioned upon certain limitations. The limitations included but were not limited drug and alcohol screening, and individual therapy sessions. On November 19, 2007, the Board granted Ms. Nolden an initial stay of the suspension. On December 15, 2008 the Board reduced Ms. Nolden's required drug screenings. Ms. Nolden is currently testing at 48 times per year.

On or about August 1, 2012, Ms. Nolden petitioned the Board for another reduction in her required drug screening. Based upon the information of record presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the request of Jennifer Nolden (#748-23) to reduce her required drug screens to 24 times per year including 1 hair specimen, be and hereby is, GRANTED.
