On September 3, 2008, the Wisconsin Dentistry Examining Board granted Respondent an initial stay of the suspension of his dentistry license, (#3977-15), pursuant to the Board Order dated January 9, 2008 (the "Order"). The stay was removed due to violation of the Order on January 31, 2011 and was reinstated on June 27, 2011. The Order provided that the stay is continuous contingent upon his compliance with the terms and conditions of the Board Order.

Information has been received by the Department Monitor that Respondent is in violation of the January 9, 2008 Order.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and Thomas J. Radke's dentistry license (#3977-15) is SUSPENDED for an indefinite period.

IT IS FURTHER ORDERED that Respondent may petition the Board for a stay of suspension upon demonstrating, to the satisfaction of the Board or its designee, that Respondent has been in compliance with the provisions of Sections C and D of this Order for the most recent three (3) consecutive months.

This Order is effective five (5) days from the date hereof.
