On January 26, 2012, the Board of Nursing considered the petitioner's request for modification to the Final Decision and Order of the Board dated December 13, 2007 to decrease the frequency of drug screens and waive the 600 hours of active practice per year requirement. Based upon the information of record which shows compliance with the terms and conditions of the Order, the Board now finds and makes the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations on the registered nurse license of Todd J. Rademan, R.N. (#137557-30) to decrease the frequency of drug screen testing to at least 28 times per year urine screens and one annual hair test is GRANTED.

IT IS FURTHER ORDERED that the request to waive the 600 hours of active practice per every year of nursing practice in compliance with the terms and conditions is DENIED based on insufficient documentation of the ability to handle nursing practice while in the recovery process.
