On February 23, 2012, the Board of Nursing considered the petitioner's request for full reinstatement of her registered nurse which was suspended by the Board pursuant to the Final Decision and Order of the Board dated September 3, 2009. The information of record shows that petitioner failed to submit quarterly audit reports concerning the Community Based Residential Facilities (CRRF) which she had previously owned and operated in her capacity as a registered nurse. The extensive health and safety violations at the CBRFs resulted in a determination by the Board that petitioner had engaged in unprofessional conduct and was the basis for the disciplinary action. The Board's original order suspended the petitioner's license for an indefinite period and required that she complete continuing education in addition to the audit requirements.

The record further shows that although petitioner has been given ample time since the issuance of the Board's order to attain compliance, she has failed to act promptly to secure the audits. As a result, petitioner claims that she is unable to fulfill this requirement because the facility has changed ownership and the records or information required for an audit are no longer available. Accordingly, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the registered nurse license of DELORES MOYER, R.N. (lic. #48993-30) is DENIED.

IT IS FURTHER ORDERED that the suspension of the petitioner's license shall be lifted and a PERMANENT LIMITATION shall be placed upon petitioner's license. The limitation shall require that petitioner disclose and provide a copy of the orders of the

Board to any private or public entities which regulate nursing homes or community based residential facilities, if petitioner should pursue or acquire, in her capacity as a registered nurse or while holding an active registered nurse license, any business interest as an investor, owner, director or employee of such facilities.
