On February 23, 2012, the petitioner appeared before the Board of Nursing in support of her request for a stay of suspension. The stay of suspension is available based upon proof of petitioner's compliance with the Final Decision and Order of the Board dated December 4, 2008. Petitioner's initial stay of suspension was removed on September 21, 2011, due to her failure to comply with the Board order drug testing protocols.

In addition to consideration of the petition for a stay of suspension, the Board considered the petitioner's emotional demeanor during her appearance and a report from the department monitor concerning petitioner negative interactions and inability to understand or follow the terms of the order. Based upon all of the information presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a stay of suspension of the registered nurse of KARIN KACZMAREK, R.N. (lic. #120127-30) is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall submit proof of three (3) months successful compliance with the Board order prior to submitting a petition for a stay of suspension.

IT IS FURTHER ORDERED that petitioner shall also submit a current AODA assessment and a comprehensive psychological evaluation by a Board-approved treatment provider prior to submitting a petition for a stay of suspension.

IT IS FURTHER ORDERED that petitioner shall also submit verification of her NA/AA meeting attendance prior to submitting a petition for a stay of suspension.

All reports, records or petitions shall be mailed or faxed to the Department Monitor who shall submit the petitioner's request before the Board when the requirements are met.
