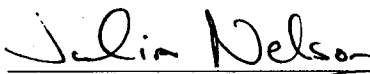
On November 1, 2012, the Board of Nursing considered the petitioner's request for the modifications to decrease the frequency of drug screens, to terminate AA/NA meeting requirement and to allow her to work in pool, home health and agency settings pursuant to the Final Decision and Order of the Board dated January 22, 2009. Based upon the information of record which shows petitioner's lack of compliance with the terms and conditions under the order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations of the registered nurse license of Mary Jo Trunnell (#89206-30) to decrease the frequency of drug screens, to terminate AA/NA meeting requirement and to allow her to work in pool, home health and agency settings is DENIED.
