On May 3, 2012, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated April 2, 2009 to terminate therapy and attendance at AA/NA meetings and allow access to controlled substances for administration to patients in her nursing practice. Based upon the information of record which shows compliance with the terms and conditions of the Order and her therapist supports the termination of therapy, the Board now finds and makes the following:

ORDER


NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations on the registered nurse license of Lisa Wickline (#98101-30) to terminate attendance at AA/NA meetings is DENIED as attendance at AA/NA meetings is an integral part of the recovery process.

IT IS FURTHER ORDERED that the request to terminate the therapy requirement is GRANTED.

IT IS FURTHER ORDERED that the request for access to controlled substances for the purpose of medication administration to patients in the workplace is GRANTED
