By Order dated April 6, 2009, the Wisconsin Barbering and Cosmetology Examining Board (now, the Wisconsin Cosmetology Examining Board) ordered Respondent to pay a forfeiture and costs of the proceedings (costs) of one thousand (\$1,000) dollars. The Respondent was to make payments in installments of two hundred dollars (\$200), with the first payment due on March 1, 2009 and quarterly until paid in full.

According to records maintained by the Department of Safety and Professional Services, the Respondent has failed to make any payments.

Pursuant to the terms of the April 6, 2009 Order, failure to make the payment as required constitutes a violation of the Order and shall result in suspension of the Respondent's licensee without further notice or hearing.

Based upon the entire record in the above-captioned matter, the Board makes the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Ronette L. Tolliver's practitioner license (#78721-82) is SUSPENDED until she has complied with payment of costs and forfeitures as set forth in the April 6, 2009 Order.

This Order is effective five (5) days from the date hereof.
