On July 25, 2012, the Pharmacy Examining Board considered the Petitioner's request to modify the terms and conditions of the Final Decision and Order issued by the Board in this matter on June 24, 2009. Based upon the information of record, which shows compliance with the terms and conditions of the June 24, 2009 Order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request of Petitioner Gabriel J. Simons (#14497-40) for an increase in pharmacist-in-charge hours is **GRANTED**. Mr. Simons is permitted to work as a pharmacist-in-charge for a maximum of thirty-two (32) hours per week.

IT IS FURTHER ORDERED that Mr. Simon's request for a reduction in the frequency of drug screens is **GRANTED**. Mr. Simons shall undergo testing of his urine specimens at a frequency of twelve (12) times per year, with at least one hair test. Paragraph C.14 of the Final Decision and Order dated June 24, 2009 shall be modified to read:

The Approved Program shall require the testing of urine specimens at a frequency of not less than twelve (12) times per year. The Approved Program shall also require the testing of a hair sample at a frequency of not less than one (1) time per year. The frequency of such testing may be further reduced only upon a determination by the Board or its designee after receiving a petition for modification as required by Paragraph D.4. of the Final Decision and Order dated June 24, 2009.

Gabriel J. Simons shall be in full compliance with this Order and the Final Decision and Order dated June 24, 2009 as amended.
