On August 16, 2012, the petitioner appeared before the Board of Nursing in support of her request for reinstatement of her registered nurse license pursuant to the Final Decision and Order of the Board dated January 28, 2010. Based upon the information of record which shows petitioner is not in compliance with the Board Order and that she has insufficient time under the Order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the registered nurse license of MICHELLE SVOKE, R.N. (lic. #151661-30) is hereby DENIED.

IT IS FURTHER ORDERED that the frequency of the petitioner's random drug screens shall be decreased to 28 times per year with one annual hair test, until employment as a registered is obtained at which time the screens shall be increased to 48 times per year with one annual hair test.
