On January 11, 2012, the Social Worker Section considered the report on psychological evaluation prepared by Gary R. Schoener, pursuant to the Final Decision and Order of the Section dated April 14, 2010. Based upon Dr. Schoener's report, the Section now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the licensed clinical social worker license of Robert K. La Fountain (#7110-123) is LIMITED as follows:

- He shall enter into, and continue, in treatment with a treater pre-approved by the Section or its Designee. The treatment program shall be at a frequency to be determined by the Treater, however, treatment may end only with the approval of the Section or its designee. The Treater shall submit formal written reports to the Department Monitor on a quarterly basis.
- He shall submit copies of the psychological assessment, including all reports provided by Dr. Schoener, and all Orders, including subsequent Orders, to both his therapist and his supervisor.
- He shall practice only in a work setting pre-approved by the Board or its designee. He may not practice in a setting in which he works independently. His work setting and supervision shall be consistent with the recommendations in the reports provided by Dr. Schoener.

IT IS FURTHER ORDERED that the requirement in the Order dated April 14, 2010 requiring at least two years of quarterly work reports is modified to require the two years of quarterly work reports to begin with the date of employment in a preapproved work setting.

IT IS FURTHER ORDERED that all limitations and conditions of the Final Decision and Order dated April 14, 2010 remain in full force and effect.
