On July 19, 2012, the Board of Nursing considered the petitioner's request for modification of the limitations on her registered nurse license pursuant to the Final Decision and Order of the Board dated May 6, 2010 to decrease her drug screen frequency. Based upon the information of record which shows she is not currently employed in the health field, the Board now finds and makes the following:


ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations on the registered nurse license of Stephanie Hoffman (#150103-30) to decrease the frequency of drug screens is GRANTED.

IT IS FURTHER ORDERED that the frequency of drug screens shall be at least twenty-eight (28) urine screens per year and one (1) annual hair test until such time as Stephanie Hoffman obtains nursing employment. At such time the drug screen frequency shall increase to at least forty-eight (48) urine screens per year and one (1) annual hair test.
