On March 22, 2012, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated September 2, 2010 to allow the termination of the therapy requirement, remove the requirement of verification of attendance at AA/NA meetings and to reduce the frequency of drug screens. Based upon the information of record which shows lack of therapist endorsement for termination of therapy, the Board now finds and makes the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for modification of the limitations on the registered nurse license of Melissa S. Anderson (#153590-30) to terminate the therapy requirement and removed the requirement of verification of AA/NA meetings attendance is DENIED. Attendance at AA/NA meetings is an adjunct to recovery and the verification of attendance is a standard requirement.

IT IS FURTHER ORDERED that the Petitioner's drug screen frequency shall be reduced to at least 28 urine screens per year and at least one annual hair test.
