On June 7, 2012, the Board of Nursing considered the petitioner's request for modification of the limitation on her license pursuant to the Final Decision and Order of the Board dated January 27, 2011 to terminate the required participation in a drug screen monitoring program. Based upon the information of record which shows insufficient time under the Order to warrant the termination of drug screen monitoring, the Board now finds and makes the following:

ORDER
