On August 16, 2012, the Wisconsin Board of Nursing considered the petitioner's request for modification of the Final Decision and Order of the Board dated January 27, 2011 to decrease the frequency of her drug screens and to terminate therapy. Based upon the following information of record; 1) petitioner does not have the therapist's support for termination of therapy; 2) petitioner has not submitted the required therapy reports; 3) costs of the disciplinary proceeding appear not to have been paid; and 4) petitioner has not been in compliance with terms of the order for the required period of time to warranted a decrease in drug screens, the Board now finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request of DENISE A. DENTON, R.N. (lic. # 111091-30) for modifications to the Board's Order is DENIED.

IT IS FURTHER ORDERED that petitioner shall submit a list of her current prescription medications and a report from her therapist regarding termination of therapy. No further action is required in regard to costs which have been clarified as paid in full.
