ORDER GRANTING EXTENSION OF TIME TO PAY COSTS AND DENYING REQUEST FOR REINSTATMENT

On October 19, 2011, the Wisconsin Medical Examining Board issued a Final Decision and Order revoking the license to practice medicine and surgery of Steven B. Greenman, M.D., (#20-18938). The Board further ordered Dr. Greenman to pay all recoverable costs of the disciplinary matter. On December 14, 2011, the Board issued an Order Fixing Costs of the proceedings in the amount of \$31,578.89. The Board ordered Dr. Greenman to make payment of costs on or before January 19, 2012.

On or about January 13, 2012, Dr. Greenman informed the Board that he was unable to pay costs in the matter due to financial hardship. He requested an extension of the time to pay the costs of the proceedings and reinstatement his license to practice medicine and surgery. The Board considered the petitioner's requests at its February 15, 2012 meeting. Based on the information of record presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request of Steven B. Greenman, M.D., (#20-18938), for an extension of time to pay costs of the proceedings is GRANTED.

IT IS FURTHER ORDERED that Petitioner establish a payment plan with the Department Monitor and with approval of the Board's designee. The payment plan shall require Respondent to pay a minimum of 20% of the total costs in each of the next (5) years such that, at the end of the five years, Petitioner will have paid costs in full.

IT IS FURTHER ORDERED that the request of Steven B. Greenman, M.D., to reinstate his license to practice medicine and surgery be and hereby is, DENIED.
