On May 18, 2011, the Medical Examining Board issued a Final Decision and Order indefinitely suspending Respondent's license to practice medicine and surgery in the state of Wisconsin (#48739-20). The Board subsequently granted a stay of suspension, permitting Respondent to practice under a limited license with certain terms and conditions.

On December 12, 2012, the Medical Examining Board considered Respondent's request to modify the frequency of drug and alcohol screens and remove the limitation from his license, pursuant to the above Order. Based upon the information of record, which shows Respondent has been compliant with the terms and conditions thus far but has not demonstrated sufficient time under the Order, the Board finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Respondent's request for a modification to the frequency of drug and alcohol screens be, and hereby is, GRANTED. Dr. Berezovski shall now undergo drug and alcohol screens at a frequency of not less than 36 times per year, with one annual hair test.

IT IS FURTHER ORDERED that Respondent's request to remove the limitation from his license be, and hereby is, DENIED.

All other terms and conditions remain in full force and effect.

This order is effective the date of its signing.
