ORDER GRANTING REQUEST FOR EXSTENSION OF TIME

On June 15, 2011, the Wisconsin Medical Examining Board issued a Final Decision and Order reprimanding the license to practice medicine and surgery of Rudy V. Byron, Jr., M.D., (#20-42218). The Board also imposed a continuing education limitation requiring Dr. Byron to successfully complete the Intensive Course in Controlled Substance Management offered by Case Western Reserve University on December 6-9, 2011; or within 180 days of the Order, complete a course substantially equivalent to the Intensive Course in Controlled Substance Management which had been preapproved by the Board.

On or about December 29, 2011, Dr. Byron informed the Board that he was unable to attend the Case Western Reserve course scheduled during December 2011 due to the course being full. The petitioner completed the "Physician Prescribing" course offered by the University of California at San Diego in August of 2011. However, this course was not approved by the Board. Therefore, the petitioner requests an extension of time to complete the Intensive Course in Controlled Substance Management offered by Case Western Reserve. The course is scheduled for May 8-11, 2012. The Board considered the petitioner's request at its February 15, 2012 meeting. Based on the information of record presented, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for an extension of time to attend the Intensive Course in Controlled Substance Management offered by Case Western Reserve on May 8-11, 2012, of Rudy V. Byron, M.D., (#20-42218), be and hereby is, GRANTED.
