### PROCEDURAL HISTORY

On June 27, 2011, for the reasons stated in the Final Decision and Order of the same date, the Barbering and Cosmetology Examining Board revoked Respondent Sara J. Bukachek's barbering and cosmetology manager license (# 31758-81). The revocation was to continue in effect until Respondent completed the remaining 500 employment hours needed for her to meet the minimum requirements for that credential. The Board further required Respondent to pay a forfeiture of \$ 2,500.00 in five payments of \$500.00 each, as well as costs of the proceeding in the amount of \$ 1,000.00 within 90 days. At any time after completing the necessary 500 employment hours, Respondent could petition for reinstatement of her manager license. Such petition would be granted if it affirmatively and unequivocally stated in writing, signed under oath, that Respondent was in compliance with several conditions detailed in the June 27, 2011 Order.

On December 5, 2011, the Department Monitor received a petition from Respondent for reinstatement of her manager license. The Board did not consider this request at the January 30, 2012 meeting as all conditions of the Order had not been met.

On March 5, 2012, Respondent re-petitioned for reinstatement of her manager's license and provided an affidavit dated March 6, 2012.

The Barbering and Cosmetology Examining Board considered this matter at its meeting on April 2, 2012, and based upon the evidence presented, makes the following:

### FINDINGS OF FACT

Respondent has complied with the requirements of the Board's Order in this matter.

### ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of Sara J. Bukachek's barbering and cosmetology manager license (# 31758-81), be, and hereby is, GRANTED.
