1. On or about December 6, 2011, Dr. Chandra S. Reddy, M.D. (Petitioner), requested reinstatement of his unrestricted license to practice medicine and surgery in Wisconsin. That license, number 47052-20, is active, limited, and current until October 31, 2013.
2. On January 18, 2011, Petitioner's Petition for Full Licensure and supporting documents were presented to the Medical Examining Board.
3. The Board, having reviewed the Petition and supporting documents, finds that Petitioner has provided proof sufficient to establish that he has fully complied with the terms of the Board's previous Final Decision and Order, issued on July 20, 2011, in case no. 10MED374.

ORDER


NOW, THEREFORE, IT IS HEREBY ORDERED:

Limitations on Dr. Chandra Reddy's license to practice medicine and surgery are removed. Dr. Reddy's license, number 47052-20, is restored to full status.
