BACKGROUND

On February 8, 2012, the Veterinary Examining Board considered the Respondent's request for removal of the suspension imposed upon her license on October 7, 2011 for violation of the Final Decision and Order of the Board dated August 3, 2011. Based upon the requirement to have an active license to fulfill the remaining requirements of the Final Decision and Order dated August 3, 2011, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of Esta L. Parrish's license no. 2275-50 is lifted and her LIMITED license is reinstated.

IT IS FURTHER ORDERED that all other terms and conditions of the Final Decision and Order dated August 3, 2011 not otherwise modified herein remain in full force and effect.

Esta L. Parrish shall be in full compliance with this Order and the Final Decision and Order dated August 3, 2011.
