#### BACKGROUND

- 1. The Wisconsin Chiropractic Examining Board (Board) approved a Final Decision and Order pursuant to a Stipulation signed by the Respondent, Jerod J. Bergman, D.C (license #3888-12), and the Division of Enforcement.
- 2. Pursuant to the Order, dated August 11, 2011, the Respondent was reprimanded and had limitations placed on his license, including the requirement to take and pass the postlicensure exam for ethics and boundaries offered by the NBCE, or such other continuing education deemed appropriate and pre-approved by the Board or its designee.
- 3. On January 5, 2012, the Respondent petitioned the Board seeking approval to take an ethics course specifically tailored for him by Dr. John B. Wolfe in lieu of completing the post-licensure ethics and boundaries exam. In the alternative, the Respondent requested an extension of time in which to fulfill the requirement to take the NBCE exam.

The Board considered this request at its January 26, 2012 meeting, and based upon the record presented, makes the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the Respondent's request to take the proposed continuing education in lieu of passing the NBCE post-licensure exam for ethics and boundaries is DENIED.

IT IS FURTHER ORDERED that the Respondent's request for an extension of time to fulfill the requirement to take the NBCE exam is GRANTED as follows: Respondent shall sit for the February 12, 2012 administration of the NBCE exam if permitted by NBCE. If not permitted to sit for the 2/12/12 exam administration, Respondent is granted an extension of time, until April 5, 2012, to take and pass the NBCE post-licensure exam for ethics and boundaries. No further extensions will be granted.

IT IS FURTHER ORDERED that, except as to the requirement that respondent take and pass either the 2/12/12 or the 4/5/12 administration of the NBCE examination, all other provisions, conditions and requirements set forth in the Board's Order, dated August 11, 2011, remain in effect.
