PROCEDURAL HISTORY

On September 12, 2011, the Barbering and Cosmetology Examining Board reprimanded Respondent manicurist Hoang T. Nguyen (license # 6175-85) and ordered him to, within 90 days of the Order, pay a forfeiture of \$1,425.00 and costs of the proceeding of \$211.00.

Also on September 12, 2011, Respondent Supreme Nails (license # 3708-71) was reprimanded and ordered to pay a forfeiture of \$1,425.00 and costs of the proceeding of \$211.00 within 90 days of the Order.

The Board reviewed this matter at its January 30, 2012 meeting pursuant to Respondents' October 3, 2011 petition requesting a payment plan. Based upon the record presented, the Barbering and Cosmetology Examining Board makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the Respondents' request for a payment plan is GRANTED as follows:

- 1. Respondent Hoang T. Nguyen (lic# 6175-85), shall, within 30 days of the date of this Order, make a payment of not less than \$500.00. Payments in the amount of \$250.00 shall be made monthly thereafter until the total amount of the fines and costs assessed against Nguyen has been paid.
- 2. Respondent Supreme Nails (lic # 3708-71), shall, within 30 days of the date of this Order, make a payment of not less than \$500.00. Payments in the amount of \$250.00 shall be made monthly thereafter until the total amount of the fines and costs assessed against Supreme Nails has been paid.
- 3. Payment of forfeitures and costs shall be made using certified funds (cashier's check, money order or certified check) payable to the Wisconsin Department of Safety and Professional Services and sent to:
