On October 6, 2011, the Chiropractic Examining Board issued a Final Decision and Order reprimanding Respondent and limiting her license to practice chiropractic (#2489-12). Pursuant to the Order, Respondent shall pay \$2500.00 in costs of the proceeding within 180 days and, within 60 days, shall engage the services of a pre-approved chiropractor to serve as a Monitor. The Monitor shall submit quarterly letters to the Board as described in the Order.

On October 4, 2012, the Chiropractic Examining Board considered Respondent's request for a payment plan and an extension of time to pay the costs of the proceeding. Based upon the information of record, which shows Respondent has not been compliant with the terms of the October 6, 2011 Order, the Board finds and makes the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request of Respondent, Wanda J. Erdman, D.C., for a payment plan and an extension of time to pay the costs of the proceeding be, and hereby is, DENIED.

IT IS FURTHER ORDERED that Respondent shall become fully compliant with <u>all</u> terms and conditions of the October 6, 2011 Final Decision and Order no later than November 12, 2012.

IT IS FURTHER ORDERED that in the event Respondent fails to become fully compliant by November 12, 2012, her license to practice chiropractic (#2489-12) shall be SUSPENDED, without further notice, hearing or action from the Board.

This Order is effective the date of its signing.
