On July 25, 2011, the Department of Safety and Professional Services ("Department") suspended Respondent's clinical substance abuse counselor credential (#13092-132). suspension was to continue until Respondent submits proof that he completed continuing education in the subjects of ethics and financial relationships and until he has been assessed as competent in these areas by the Department. Additionally, pursuant to the Order Fixing Costs dated February 2, 2012, Respondent was ordered to pay \$3224.92 in costs by August 2, 2012.

On May 25, 2012, the Department issued an Order Approving Continuing Education Courses and Imposing Requirement for Assessment of Competency. "Dual Relationships: Ethical Clinical Aspects of Dual Relationships in Psychotherapy" and "Ethical Issues with Fees, Billing, and Collections" were approved to satisfy the education requirements of the Order.

Respondent has submitted proof verifying his completion of the above courses, as well as written statements exhibiting his competency in the above subjects. Furthermore, because he is unable to pay the costs as ordered, Respondent is requesting a payment plan and an extension of time in order to fulfill this obligation. Based on the documentation received by the Department, the following is entered:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the suspension imposed upon Kenneth A. Sieczkowski's clinical substance abuse counselor credential (#13092-132) is REMOVED.

IT IS FURTHER ORDERED that the request for a payment plan and extension of time to pay the proceeding costs is GRANTED. Respondent shall make four (4) equal payments of \$806.23 within one (1) year from the date of this Order until the costs are paid in full. If Respondent fails to pay the costs as set forth in a timely manner, Respondent's credential SHALL BE SUSPENDED, without further notice or hearing, until he has paid the costs are paid in full.

This Order is effective on the date hereof.
