The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board (Section). The Section has reviewed this Stipulation and considers it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Dan G. Feaster ("Respondent") was born on May 23, 1957 and is licensed as a clinical social worker in the State of Wisconsin (license # 2511-123). This license was first granted on May 4, 1994.
2. Respondent's most recent address on file with the Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board is 3192 Breeze Drive, Sun Prairie, Wisconsin.
3. On September 16, 2009, Respondent attended a social gathering that was associated with the Wisconsin Juvenile Officers Association's annual convention, at which Respondent volunteered his time to make a keynote presentation.
4. At the social gathering, Respondent became intoxicated and experienced memory fugue or blackout and behaved inappropriately toward five women.
5. On February 14, 2011, Respondent was convicted of four counts of misdemeanor Disorderly Conduct in Adams County for the incident on September 16, 2009.
6. Since May 2, 2010, Respondent has been attending counseling sessions regularly with Dr. R.J.

CONCLUSIONS OF LAW

1. The Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 457.26 and has authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
2. Respondent, by violating a law substantially related to practice, has committed unprofessional conduct as defined by Wis. Admin. Code § MPSW 20.02(2) and is subject to discipline pursuant to Wis. Stat. § 457.26(2)(f).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Dan G. Feaster (license No. 2511-123) is **REPRIMANDED**.

IT IS FURTHER ORDERED that:

2. For a period of at least one (1) year from the date of this Order, Respondent's license to practice as a clinical social worker in the State of Wisconsin is **LIMITED** as follows:

- a. Respondent shall provide a copy of this Final Decision and Order immediately to supervisory personnel at all settings where Respondent works as a clinical social worker.
- b. Respondent shall notify the Department Monitor of any change of employment during the time in which the Order is in effect. Notification shall occur within fifteen (15) days of a change of employment and shall include an explanation of the reasons for the change.
- c. Respondent shall continue in psychotherapy with a psychotherapist pre-approved by the Section or its designee. Requests for approval shall be submitted to the Department Monitor at the address below.
- d. Respondent's psychotherapist shall provide written reports on Respondent's treatment on a quarterly basis, as directed by the Department Monitor. Reports shall be submitted to the Department Monitor at the address below. It shall be Respondent's responsibility to insure that the reports are made in a timely manner.
- e. After one year from the date of this Order, Respondent may petition the Section to remove the Limitation. Requests for removal of the Limitation shall be submitted to the Department Monitor at the address below.


3. Respondent shall, within ninety (90) days from the date for this Order, pay costs of this proceeding in the amount of EIGHT HUNDRED DOLLARS (\$800.00). Payment shall be made payable to the Wisconsin Department of Safety and Professional Services, and mailed to:

4. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Section may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely pay costs as ordered, Respondent's license to practice as a clinical social worker (license #2511-123) shall be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.

5. This Order is effective on the date of its signing.
