FINDINGS OF FACT

1. Adam T. Hampton (Applicant) has filed an application for a credential to practice as a private security person in Wisconsin.
2. Information received in the application process reflects that on or about January 3, 1996, April 29, 1996 and October 20, 2009, Applicant was convicted of violations of Wis. Stat. §947.01 [Disorderly conduct] arising from three separate incidents.
3. Limitations upon the Applicant's license are necessary to ensure the safety and welfare of the public.

CONCLUSIONS OF LAW

1. The Wisconsin Department Safety and Professional Services has jurisdiction over this matter pursuant to Wis. Stat. § 440.26.
2. The facts and circumstances of the convictions referenced above substantially relate to the practice of a private security person. Applicant by his conduct is subject to action against his license pursuant to Wis. Stat. § 440.26.

ORDER

NOW, THEREFORE, IT IS ORDERED that ADAM T. HAMPTON is GRANTED a PRIVATE SECURITY PERMIT subject to the following LIMITATIONS, TERMS AND CONDITIONS:

1. Applicant shall provide a copy of this Final Decision and Order immediately to supervisory personnel at all settings where Applicant works or applies to work as a private security person.
2. Until otherwise ordered by the Department, Applicant shall not be permitted to carry a firearm in conjunction with his employment as a private security permit holder.
3. It is Applicant's responsibility to arrange for his security guard supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, as directed by Department Monitor. These reports shall describe the Applicant's activities and verify that he is in compliance with the laws governing the practice of a private security person and the terms of this Order.
4. Applicant shall not work in any settings involving crowd control without the express written permission of the Department Monitor.
5. Applicant shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change. Applicant shall in addition report any arrest or conviction within 48 hours of the arrest or entry of conviction.
6. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant
7. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

8. Applicant may petition the Department for modification of the terms of this Order after one year from the effective date of this order. Any such petition shall be accompanied by a written recommendation from Applicant's employer expressly supporting the specific modifications sought. Denial of a petition in whole or in part shall not be considered a denial of a license within the meaning of Wis. Stats. § 227.01(3)(a), and Applicant shall not have a right to any further hearings or proceedings on the denial.
9. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

- 10 Failure by Applicant to timely comply with the terms of this limitation and/or any further criminal conviction shall result in the revocation of Applicant's security permit without further notice, hearing or other proceeding. A violation of this Order may alternatively be the basis for a summary suspension under Wis. Admin. Code § SPS 6 or separate disciplinary action under Wis. Stat. § 440.26(6).
