The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Professional Counselor Section (Section). The Section has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Section in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Kristin R. Brighty ("Respondent") was born on February 18, 1974 and is licensed as a Professional Counselor-in-Training in the State of Wisconsin (license #1149-226). This license was first granted on July 26, 2011.
2. Respondent's most recent address on file with the Wisconsin Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board is 3322 S. Moorland Rd., New Berlin, Wisconsin.
3. At all times relevant to this proceeding, Respondent worked as a psychotherapist at Bridge Halfway House (Bridge), located in Milwaukee, Wisconsin. Bridge is a part of Wisconsin Community Services, Inc. and is contracted with the Department of Corrections and Department of Health Services to provide halfway house services, drug treatment therapy and social work services.
4. From February 2010 to May 2010, Client J.S. resided at Bridge. Client J.S. was originally assigned to another counselor, but was later transferred to Respondent in late March.
5. Sometime after March 2010, Respondent and Client J.S. began a sexual relationship. In October 2010, Respondent and Client J.S. married in DeKalb County, Illinois.
6. Throughout the relationship, Respondent understood that her relationship with Client J.S. was prohibited by both her employer and rules of the profession. Respondent warned Client J.S. that he cannot disclose their relationship to others, for fear of her job.
7. During her relationship with Client J.S., Respondent falsified Client J.S.'s Certificate of Completion from Bridge, stating that he completed phases 2 and 3 of the programming when he in fact did not. Respondent also did not report a number of Client J.S.'s probation violations.
8. On September 1, 2011, Client J.S. reported the relationship and marriage to Respondent's employer. Respondent initially denied the allegations, but eventually admitted to them in a letter addressed to her employer on September 5, 2011.

CONCLUSIONS OF LAW

1. The Professional Counselor Section of the Wisconsin Marriage and Family Therapy, Professional Counseling and Social Work Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 457.26(2), and is authorized to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
2. The conduct described above constitutes unprofessional conduct as defined by Wis. Admin. Code § MPSW 20.02(11) and subjects Respondent to discipline pursuant to Wis. Stat. § 457.26(2)(f).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The license of Kristin R. Brighty to practice as a Professional Counselor-in-Training (license #1149-226) is **REVOKED**.

IT IS FURTHER ORDERED that:


