PROCEDURAL HISTORY

A formal complaint was filed in this matter on January 19, 2012. A Petition for Summary Suspension was filed and served upon Respondent on January 27, 2012.

The parties in this matter agree to the terms and conditions of the attached Interim Stipulation to this Interim Agreement and Order in this matter, subject to the approval of the Board. The Board has reviewed this Interim Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Interim Stipulation and makes the following:

FINDINGS OF FACT

1. Victoria Mondloch, M.D., Respondent, date of birth August 19, 1955, is licensed and currently registered by the Medical Examining Board (Board) to practice medicine and surgery in the State of Wisconsin, pursuant to license number 26004-20, which was first granted July 1, 1984.

- 2. Respondent's last address reported to the Department of Safety and Professional Services (Department) is W220 S3731 Hidden Court, Waukesha, WI 53189.
 - 3. Respondent specializes in obstetrics and gynecology.
- 4. On January 19, 2012, the formal Complaint was filed with the Division of Hearings and Appeals and served on the Respondent by certified mail with a return receipt requested in an envelope properly stamped and addressed to Respondent at her address of record at W220 S373 Hidden Court, Waukesha, WI 53189, and by regular mail in an envelope properly stamped and addressed to Respondent at her address of record at W220 S373 Hidden Court, Waukesha, WI 53189.
- 5. On January 27, 2012, the Respondent was provided notice of the time and place of the presentation of the Petition for Summary Suspension by certified mail with a return receipt requested in an envelope properly stamped and addressed to Respondent at her address of record at W220 S373 Hidden Court, Waukesha, WI 53189, and by regular mail in an envelope properly stamped and addressed to Respondent at her address of record at W220 S373 Hidden Court, Waukesha, WI 53189.
- 6. The allegations contained in the formal complaint involve the Respondent's obstetrical and gynecological practice only.
- 7. The parties acknowledge that, at this time, no decision has been made with regard to the validity of the allegations contained in the formal complaint filed in this matter
- 8. Pending the entry of a Final Decision and Order by the Board in this matter, Respondent voluntarily agrees to the following:
 - a. Dr. Mondloch will not engage in the practice of obstetrics.
 - b. Dr. Mondloch will, within 5 days of the effective date of this Agreement and Order, transfer any obstetrical patients under her care to an obstetrician of the patient's choice.
 - c. Dr. Mondloch will also immediately refer to another obstetrician any new patient who presents to respondent and is, or is suspected to be, pregnant.
 - d. Dr. Mondloch will immediately refer to another obstetrician and/or gynecologist any patient who presents with symptoms of abnormal bleeding or cramping where possible pregnancy of any type, including but not limited to, uterine, ectopic or molar, is part of the differential diagnosis.
 - e. Dr. Mondloch will, within 5 days of the effective date of this Agreement and Order transfer to another obstetrician and/or gynecologist of the patient's choice, any patients currently in her practice who are undergoing any infertility work-up or treatment.

- f. Dr. Mondloch will not perform any surgical or other gynecological procedures on any patient with the exception of colposcopies, pelvic examinations and pap smears. Respondent will transfer all patients requiring gynecological procedures other that colposcopies, pelvic examinations and pap smears within 5 days of the effective date of this Agreement and Order.
- g. Dr. Mondloch may continue her general office practice duties as a physician. She may perform routine physical examinations and check-ups of her patients, and may continue to monitor their conditions, such as diabetes and hypertension, and adjust their medications as needed. She may also continue to work with her patients on wellness, health and exercise initiatives and objectives, and routine programs to instill both.
- h. Dr. Mondloch may continue to perform her duties and responsibilities as Medical Director of Skin Tight Medi-Spa, located at N95 V/25901 County Line Rd., Colgate, Wisconsin. This includes the use of a laser to treat skin conditions and the removal or warts and moles. She is also permitted to give injections, such as Botox, Xeomin, Radiesse, and Juvederm.

CONCLUSION OF LAW

The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

IT IS ORDERED THAT THE STIPULATION OF THE PARTIES IS ACCEPTED.

IT IS FURTHER ORDERED that the voluntary agreement of Victoria Mondloch, M.D. as set forth above is accepted.

IT IS FURTHER ORDERED that, based upon that agreement and pending the Final Decision and Order entered by the Board in this matter:

- a. Dr. Mondloch will not engage in the practice of obstetrics.
- b. Dr. Mondloch will, within 5 days of the effective date of this Agreement and Order, transfer any obstetrical patients under her care to an obstetrician of the patient's choice.
- c. Dr. Mondloch will also immediately refer to another obstetrician any new patient who presents to respondent and is, or is suspected to be, pregnant.
- d. Dr. Mondloch will immediately refer to another obstetrician and/or gynecologist any patient who presents with symptoms of abnormal bleeding or cramping where possible

pregnancy of any type, including but not limited to, uterine, ectopic or molar, is part of the differential diagnosis.

- e. Dr. Mondloch will, within 5 days of the effective date of this Agreement and Order transfer to another obstetrician and/or gynecologist of the patient's choice, any patients currently in her practice who are undergoing any infertility work-up or treatment.
- f. Dr. Mondloch will not perform any surgical or other gynecological procedures on any patient with the exception of colposcopies, pelvic examinations and pap smears. Respondent will transfer all patients requiring gynecological procedures other than colposcopies, pelvic examinations and pap smears within 5 days of the effective date of this Agreement and Order.
- g. Dr. Mondloch may continue her general office practice duties as a physician. She may perform routine physical examinations of her patients, and may continue to monitor their conditions, such as diabetes and hypertension, and adjust their medications as needed. She may also continue to work with her patients on wellness, health and exercise initiatives and objectives, and routine programs to instill both.
- h. Dr. Mondloch may continue to perform her duties and responsibilities as Medical Director of Skin Tight Medi-Spa, located at N95 V/25901 County Line Rd., Colgate, Wisconsin. This includes the use of a laser to treat skin conditions and the removal or warts and moles. She is also permitted to give injections, such as Botox, Xeomin, Radiesse, and Juvederm.

IT IS FURTHER ORDERED that if the Board determines that there is probable cause to believe that Respondent has violated any term of this Agreement and Order, the Board may, without further hearing, order that the license and registration of Respondent be immediately suspended until entry of the Final Decision and Order in the underlying matter by the Board.
