- 1. On January 19, 2012, the Division of Enforcement (DOE) filed a formal complaint alleging that Dr. Victoria J. Mondloch, M.D., Respondent/Petitioner had practiced below the standard of minimal competence in obstetrical and gynecological surgical practice. The matter is currently pending, and the allegations remain unproven.
- 2. On February 15, 2012, Respondent/Petitioner and DOE entered into a stipulated agreement to an interim order that limited Respondent/Petitioner's license to practice medicine and surgery.
- 3. The Department of Regulation and Licensing reported the interim order to the National Practioner's Data Bank (NPDB).
- 4. On April 13, 2012, Respondent/Petitioner asked the Board to immediately withdraw or remove the report and the interim order from the NPDB.
- 5. On April 18, 2012, Respondent/Petitioner appeared before the Medical Examining Board, personally and with her attorney to answer questions and argue in favor of her Petition.
- 6. Respondent/Petitioner explained that the databank report prohibited her from obtaining liability insurance, which in turn made employment as a physician

impossible. Respondent/Petitioner represented that it was the NPDB and not the interim order that created the insurance problem.

- 7. On April 18, 2012, the Board determined that the Department of Safey and Professional Services--and not the Board--made the report to NPDB.
- 8. Because the Department of Safety and Professional Services made the report, the Department and not the Wisconsin Medical Examining Board has the authority withdraw or amend the NPDB report in this matter.

ORDER

NOW, THEREFORE, IT IS ORDERED that the Wisconsin Medical Examining Board (MEB) hereby DENIES the Petition for Removal of Interim Order From the National Practitioner Data Bank.
