On March 21, 2012, the Wisconsin Medical Examining Board issued a Final Decision and Order reprimanding the license to practice medicine and surgery of Eugene C. Rigstad M.D., (#28574-20). The Board also imposed the following limitations on Dr. Rigstad's license: he must provide a copy of the order to his supervisor and if he changes his practice setting he must report the Order to his new employer, he must obtain a professional mentor who he must meet with on a monthly basis, he must obtain treatment from a psychotherapist, and he may not see any female patients in a clinical setting without the presence of a chaperone, nurse, or nursing assistant.

Dr. Rigstad is now requesting removal of the restriction requiring him to conduct treatment in the presence of a chaperone. The full board considered the information of record and voted to reject a motion to grant the Petition, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request of Eugene Rigstad, M.D., (#28574-20) be and hereby is, DENIED
