The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Barbering and Cosmetology Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Ariel S. Halverson (dob 07/27/1990) was licensed in the State of Wisconsin as a barbering or cosmetology practitioner, having license number 90862-82, first issued on 4/12/2010 and expired on 4/1/2011. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 3570 S. Sandlewood Dr., New Berlin, WI 53151.

2. Respondent practiced barbering or cosmetology in her parents' house at 3570 S. Sandlewood Dr., New Berlin, WI 53151, which is not a licensed barbering or cosmetology establishment.

CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
2. By the conduct described in the Findings of Fact, Respondent violated Wis. Stat. § 454.08(1)(b) and Wis. Admin. Code § BC 3.01(1) by practicing barbering or cosmetology outside of a licensed establishment.
3. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

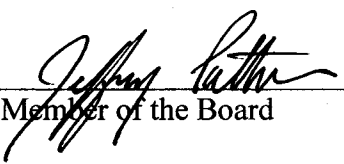
ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. The attached Stipulation is hereby accepted.
2. Respondent Ariel A. Halverson is hereby REPRIMANDED.
3. Within 90 days of the date of this Order, Respondent shall pay a FORFEITURE in the amount of \$100 and COSTS of this matter in the amount of \$125.
4. Payment of forfeiture and costs shall be made payable to the Wisconsin Department of Safety and Professional Services and sent to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the forfeiture and costs as ordered, Respondent's license (no. 90862-82) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the forfeiture and costs.
6. This Order is effective on the date of its signing.
