BACKGROUND

On April 18, 2012, the Medical Examining Board (Board) issued a Final Decision and Order reprimanding Dr. William G. Sybesma and limiting his license to practice medicine and surgery. The limitations imposed required Dr. Sybesma to refrain from performing any endoscopic surgeries using a 75 degree sinus shaver until further order form the board. On or about September 5, 2012, Dr. Ingalls petitioned the Board, via his attorney, for full reinstatement of his license.

Based upon the information of record, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to remove all restrictions and reinstate the license to practice medicine and surgery of William G. Sybesma, M.D. (21464-20) be, and hereby is, GRANTED.
