The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Justin A. Schneider is licensed in the State of Wisconsin as a Private Security Person, having license number 108-31766, first issued on 09/12/2006 and current through 08/31/2012. Respondent Schneider's most recent address on file with the Department is 1648 West Farragut Avenue, Chicago, IL 60640.
- 2. On or about July 6, 2010, Mr. Schneider submitted a renewal application to the Department and answered "NO" to the following question:

HAVE YOU BEEN CONVICTED WITHIN THE PAST TWO YEARS OF A FELONY, A MISDEMEANOR OR A VIOLATION OF ANY STATE OR LOCAL LAW (OTHER THAN TRAFFIC) THAT IS PUNISHABLE BY A FORFEITURE, OR, ARE CHARGES PENDING? (If YES, provide information.)

- 3. A Criminal Information Bureau check revealed an Assault/Battery on Another charge for Mr. Schneider within the two years preceding July 6, 2010. The Department subsequently opened this case for investigation.
- 4. Court records obtained during the course of the Department's investigation revealed that on or about September 8, 2008, Mr. Schneider was charged with Assault/Battery on Another. The charge was amended to Disorderly Conduct and Mr. Schneider was convicted on March 4, 2009 (Shorewood Municipal Court, Citation Number 14868) and was ordered to pay a forfeiture.
- 5. Mr. Schneider failed to notify the Department of the conviction within 48 hours after the entry of the judgment of conviction.
- 6. In resolution of this matter, Mr. Schneider consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent Justin A. Schneider engaged in conduct reflecting adversely on professional qualification pursuant to Wis. Admin. Code § RL (now SPS) 35.01(17) by providing false information in the application for a credential.
- 3. By the conduct described in the Findings of Fact, Respondent Justin A. Schneider has engaged in conduct reflecting adversely on professional qualification pursuant to Wis. Admin. Code § RL (now SPS) 35.01(2) by violating a law, the circumstances of which substantially relate to the practice of a private security person.
- 4. By the conduct described in the Findings of Fact, Respondent Justin A. Schneider violated Wis. Stat. § 440.26(4m)(b) and Wis. Admin. Code § RL (now SPS) 35.01(2) by failing to report his conviction within 48 hours of the judgment of conviction.
- 5. As a result of the violations noted in the Conclusions of Law, Respondent Justin A. Schneider is subject to discipline pursuant to Wis. Stat. § 440.26(6)(a) and Wis. Admin. Code § SPS 35.01.

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. Respondent Justin A. Schneider (license number108-31766) is hereby REPRIMANDED.
