The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Kimberly A. Tauscheck, R.N., (DOB 04/13/1969) is licensed as a professional nurse in the State of Wisconsin (license no. 113941-30). This license was first granted on September 24, 1993.

- 2. Respondent's most recent address on file with the Department of Safety and Professional Services is W6728 County U, Plymouth, WI 53073.
- 3. On May 6, 2010, the Wisconsin Board of Nursing issued a Final Decision and Order (Order) against Respondent in which Respondent's license to practice as a professional nurse was indefinitely suspended with no stay until Respondent petitioned the Board and provided proof that she is in compliance with provisions of the Order.
 - 4. The Order included the following practice limitation:

Respondent shall not work as a nurse or other health care provider in a setting in which Respondent passes controlled substances. In the event that Respondent, in the course of her duties in her current position as nursing supervisor, must pass a controlled substance, she must have a witness to the administration and the witness must sign the medication administration record. All controlled substances to which Respondent has access must be audited weekly by another licensed professional.

- 5. The Order was based on Respondent having submitted fraudulent prescriptions for narcotic drugs to various pharmacies in Wisconsin. Respondent stole prescription pads from two physicians and forged their signatures. Respondent was convicted of three counts of possession of illegally obtained prescription drugs and was sentenced to two years probation.
- 6. Respondent never petitioned the Board for a stayed suspension; her license has been suspended since May 14, 2010.
- 7. Despite the Order, Respondent remained employed as a supervising professional nurse in Franklin, Wisconsin.
- 8. On July 21, 2010, Respondent's employer allowed her access to witness wasting of controlled substances, but her access to dispense controlled substances remained denied.
- 9. An investigation of Respondent's access to controlled substances revealed that between February 5, 2011 present, Respondent dispensed controlled substances on 18 occasions. Additional chart review revealed that in the same period, Respondent administered controlled substances without a witness to the administration and without a witness signing the medication administration record on 33 occasions.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

- 2. The conduct described in paragraph 7 above constitutes a violation of Wis. Admin. Code § N 5.03(1) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(b).
- 3. The conduct described in paragraphs 7-9 above constitutes a violation of Wis. Admin. Code § N 7.04(14) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).
- 4. The conduct described in paragraph 9 above constitutes a violation of Wis. Admin. Code § 7.04(2) and subjects Respondent to discipline pursuant to Wis. Stat. § 441.07(1)(d).

ORDER

IT IS ORDERED:

- 1. Kimberly A. Tauscheck's right to renew her license as a professional nurse in the State of Wisconsin is REVOKED.
- 2. The privilege of Kimberly M. Tauscheck to practice nursing in the State of Wisconsin, pursuant to the Nurse Licensure Compact, is REVOKED.
- 3. Respondent shall, within 120 days of the date of this Order, pay to the Department of Safety and Professional Services COSTS of this proceeding in the amount of Three Hundred Dollars (\$300.00), pursuant to Wis. Stat. § 440.22(2). Payment shall be made to the Department Monitor, as follows:
