The applicant, Janice C. Wendland, has requested the opportunity to complete a board-approved nurse refresher course to fulfill the requirements for approval of licensure of her application for re-registration of her registered nurse, pursuant to sec. 441.04, Stats. and ch. N5.08, Wis. Admin. Code. The applicant has not been employed in a position that requires a nursing license within 5 years of application.

NOW, THEREFORE, IT IS ORDERED that a limited license shall be GRANTED to the applicant for the sole purpose of allowing her to participate in and complete the clinical portion of a board-approved nurse refresher course. The limited license does not authorize the applicant to engage in any other nursing employment in the state of Wisconsin and is intended to be solely limited to the clinical portion of the nurse refresher course.

IT IS FURTHER ORDERED that upon successful completion of the refresher course, the applicant may petition the board for reinstatement of full and unconditional licensure.
