The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Kathleen J. Degre is licensed in the State of Wisconsin as a Private Detective, having license number 63-10732, first issued on 03/05/2003 and current through

- 08/31/2012. Respondent Degre's most recent address on file with the Department is P.O. Box 1907, Eau Claire, WI 54702.
- 2. Respondent Angel Eyes Investigation is licensed in the State of Wisconsin as a Private Detective Agency, having license number 62-16276, first issued on 03/05/2003 and current through 08/31/2013. Respondent Angel Eyes Investigation's most recent address on file with the Department is P.O. Box 1907, Eau Claire, WI 54702.
- 3. On or about November 2, 2011, the Division of Enforcement received information from the Division of Credentialing indicating that there had been a lapse in the required liability insurance coverage for Angel Eyes Investigation. Division of Enforcement case number 11 RAL 011 was subsequently opened for investigation.
- 4. The documentation received indicates that the required liability insurance coverage for Angel Eyes Investigation lapsed on March 28, 2011 and was not renewed until August 23, 2011.
- 5. In resolution of this matter, Respondents Kathleen J. Degre and Angel Eyes Investigation consent to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Safety and Professional Services has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.26(6), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondents violated Wis. Admin. Code § SPS 31.034(1) and (2) by failing to maintain a surety bond or liability policy.
- 3. As a result of the violations noted in the Conclusions of Law, Respondents Kathleen J. Degre and Angel Eyes Investigation are subject to discipline pursuant to Wis. Stat. § 440.26(6)(a)2 and 4 and Wis. Admin. Code § SPS 35.01(11).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. The attached Stipulation is hereby accepted.
- 2. Respondents Kathleen J. Degre and Angel Eyes Investigation are hereby REPRIMANDED.
- 3. Within 90 days of the date of this Order, Respondent Degre shall pay COSTS of this matter in the amount of \$74.00.
- 4. Within 90 days of the date of this Order, Respondent Angel Eyes Investigation shall pay COSTS of this matter in the amount of \$74.00.

- 6. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondents' licenses. The Department in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondents fail to timely submit payment of the costs as ordered and as set forth above, Respondents' licenses (nos. 63-10732 and 62-16276) may, in the discretion of the Department, be SUSPENDED, without further notice or hearing, until Respondents have complied with payment of the costs.
 - 7. This Order is effective on the date of its signing.
