This matter was considered by the Chiropractic Examining Board at its regular meeting on August 23, 2012.

**BACKGROUND**

1. Respondent, Richard J. Ranicke, D.C. (d.o.b. 5/3/1962), 1387 Homestead Court, Hubertus, Wisconsin 53033, has been licensed as a chiropractor in the State of Wisconsin since December 14, 1989, license #2513-12.

2. The Chiropractic Examining Board on May 24, 2012 issued a Final Decision and Order pursuant to a Stipulation signed by the respondent and the Division of Enforcement. The Board Order provided in relevant part, that respondent's license be suspended and limited, as follows:

a. Richard J. Ranicke, shall locate and successfully complete a minimum of twelve (12) hours of education in record keeping and twelve (12) hours of education in patient history and examination.

b. Richard J. Ranicke shall locate and have the Board or its designee pre-approve each educational program prior to completing it.

3. By correspondence dated August 3, 2012, a petition for extension of time was filed by Michael P. Crooks, Richard J. Ranicke's attorney.

4. On August 23, 2012, the Board considered Mr. Ranicke's request for an extension of time.

Based upon the record in this matter, the Board makes the following Order:

**ORDER**

**NOW, THEREFORE, IT IS ORDERED** that the respondent, Richard J. Ranicke, be and hereby is, granted an extension of time, until November 1, 2012, to comply with the education requirements as set forth in the May 24, 2012 order.

**IT IS FURTHER ORDERED** that, except as to the extension of time for the remaining 14 hours of credit, all other provisions, conditions and requirements set forth in the Board's Order, dated August 23, 2012, remain in effect.

This order is effective on the date it is signed by a designee of the Chiropractic Examining Board.
